1. The first trustees shall be the permanent and life time trustees of the trust. The permanent trustees and additional trustees collectively are referred to as the 'board of trustees' and in short 'board'.
2. The permanent trustees shall have the power to appoint and co-opt additional trustees. The minimum number of trustees be three and shall not be exceed eighteen in all, at given point of time.
3. The succession to the office of the trustee on vacancy shall be by way of a resolution of the will of the majority of trustees.
4. Any of the additional trustees may be removed or impeached by a majority resolution of the board of trustees present and voting.
5. Among the first trustees under this deed shall be the president of the trust till alternative arrangements are made or till such time the board of trustees decided to appoint a new president among them.
6. The board of trust shall constitute governing council, which shall supervise and guides the board of trust for the smooth working of the trust. The governing council shall initially consist of the following:
7. The board may nominate the additional members to the governing council, when deemed expedient in the interest of the trust, from time to time.
8. Any person who may have been invited, appointed or associated with for any special purpose or general purpose shall not be trustee.

9. A Trustee may resign his office by letter submitted to the Board of Trustees. Such Trustee shall continue to hold the office until such resignation accepted by the Board of Trustee in the meeting.
10. A Trustee shall become ceases to be trustee in the following circumstances:
- In the event of he becomes lunatic.
 - In the event of he convicted by the competent Court for the offences involving moral turpitude.
 - On his death.
 - On removal by the board of Trustees, in the event of such trustee worked against the objects of the trust or for any other reason if he become unfit to continue as trustee, subject to provide him an opportunity to show cause within a reasonable time, why he should not be removed.
11. For any reason vacancy of the trustee is occurred as aforesaid, the said vacancy shall be filled up by appointing a new trustee by the 2/3rd majority of the board of trustees.

VIII POWERS AND DUTIES OF TRUSTEES:

- The board shall have the power to appoint administrators and staff members from time to time and fix remunerations and remove or terminate them even without prior notice.
- As already setout the additional trustees shall be appoint by the board of trustees unanimously.

3. The president shall have the following powers and such other powers, which are conferred by the board of trustees from time to time. ✓

- the trustees if they are found unreasonable and not in the interest of the trust.
- e) The president shall get the proceedings recorded in the proceedings book and get the signature of the trustees who have attended the meeting.
- f) The trustees may be paid such actual expenses as are incurred by them from time to time while serving objects and purposes of the trust. No other payment shall be made save the actual expenses incurred as the trustees are solely appointed to work honorary without any remuneration or expectation of any pecuniary returns. The trustees are entitled to donate money/articles/properties for the corpus of the trust as well as for management of the trust.
