- IV. Corpus amount of the trust shall be Rs.1000.00
- V. The Trust shall be Non-political non-section, non- commercial, non-profitable and non-racial organization. No person shall as a matter of right, demand any benefit from the Trust whether in the form of money, concessions, trusts or otherwise.

VI. AIMS AND OBJECTIVES:

THE OBJECTS OF THE TRUST SHALL BE AS FOLLOWS:

1. To establish, conduct and/or contribute educational and cultural institutions, colleges, schools, libraries, book Trust, reading Rooms, technical institutions,, research institutions, skill employment & Computer based training and other public charitable institutions, and training centers to provide quality Technical Education and other trainings at lower cost and to provide accommodation facilities for students, to help students by giving scholarships and to encourage poor and backward class students by giving medals and other financial assistance and also provide hostel facility.
2. To support abled and differently abled students for continuation of their Secondary and higher education, by providing them tuition fees, examination fees, text books and note books or their better prospectus. Conduct basic computer training for visually impaired students with the help of screen reading software of JAWS & NVDA, equip the students with skill based training such as computer training, Spoken English class and other technical trainings.
3. To establish take over, maintain and run the schools, residential schools, colleges or another educational institutions and to promote the education, science, technology, arts, commerce and various other faculties. To run educational institutions, agricultural colleges veterinary colleges, research centers for agriculture, Nursery, cattle, poultry, etc.,
4. To develop in children and the youth a sense of discipline and patriotism; and, to provide opportunities for self-employment and overall self-development of students and the youth.
5. To conduct lectures, seminars, symposia on all subjects connected with objects of the Trust and to arrange, organize for training and coaching classes for competitive examinations

 13. To institute studentships, scholarships, fellowship, medals, prizes etc. for bold and encourage deserving students and to provide monetary aid to students by means of scholarships for pursuing higher education.
 14. To acquire Properties or hold the agriculture or non- agriculture lands or any other properties, assets equipments, vehicles and apparatus and other assets for the purpose of attaining the above objectives and/or to distribute housing sites, tenements, farmhouse, and farms for the distribute housing sites, tenements, farm- houses, and farms for the trustees or others as desired by the trustees from time to time with the permission of the concerned authorities wherever necessary.

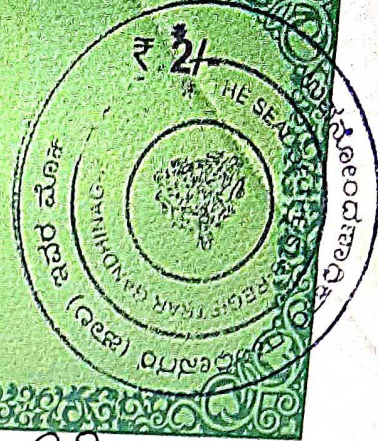
